He has handled countless other cases before judges and juries in Idaho state courts, and in federal courts in Idaho, Washington, California, Pennsylvania, and Delaware, including appeals before the Idaho Supreme Court and the U.S. Court of Appeals for the Ninth Circuit.

In recent years, Newal has leveraged his experience to add the role of mediator into his practice, where he brings the same commitment to problem-solving and civility to his mediation efforts. He has become highly sought after by parties seeking to resolve a wide array of disputes through mediation, including all manner of commercial disputes in addition to professional negligence (legal, accounting, medical malpractice), construction, employment, personal injury (catastrophic injury and wrongful death), and trusts/estates. He has conducted more than 450 mediations, including over 200 virtual mediations after becoming an early adopter of Zoom mediation during COVID. Newal is the only mediator in Idaho listed in the 2025 edition of Mountain States Super Lawyers®.

Newal's approach to problem solving, persuasion, and working with diverse stakeholders to achieve his clients' goals was shaped by his tenure in the Office of Legal Counsel on the personal staff of U.S. Attorney General Griffin Bell from 1977-1979, where he focused on national security and counterintelligence issues, including passage and implementation of the Foreign Intelligence Surveillance Act (FISA). Newal was part of the small group of lawyers who met daily for breakfast with the Attorney General.

### **CLIENT RESULTS**

Defeated motion for class certification by putative class of 850 former employees of call center terminated after close of ACA open enrollment period.

Obtained Motion to Dismiss Federal and State Securities Law and Consumer Protection Act claims brought by 26 investors alleging damages between \$5 and \$10 million against national real estate development company.

Defeated Motion for TRO/Preliminary Injunction involving misappropriation of trade secrets and breach of contract claims among members of an LLC involving a biodiesel plant and agri-business products; thereafter resolving cases in Idaho and California to achieve the client's business objectives after filing a dispositive motion before discovery.

Led the team and argued the motion for summary judgment resulting in dismissal of FCA claims exceeding \$8 billion on behalf of Fortune 100 defense contracting firm.
