#### Water Supply Development

Bill represented a large cattle feeder in connection with development and implementation of a water supply plan in the lower Arkansas River basin, which included a precedent-setting transfer of ditch company shares to non-irrigation uses.

#### Water Court Adjudications

Bill has represented industrial water users, both as applicants and objectors, in water court applications for approval of complex augmentation and exchange plans involving hundreds of wells and multiple replacement sources. He has also assisted clients with adjudication of water storage

rights involving thousands of acre feet of reservoir capacity.

### **Administrative Law**

Bill served as lead counsel for oil and gas producers in rulemaking hearings before the State Engineer which resulted in successful determinations of geographic areas and geologic formations where produced water is considered nontributary groundwater under applicable State water laws. He also served as lead counsel for a large electric utility in an adjudicatory hearing before the Colorado Ground Water Commission regarding the proposed creation of a designated groundwater basin.
