Michael has helped clients prevail in numerous court and jury trials and arbitrations involving multi-million-dollar disputes.

Michael also advises clients regarding data breaches, privacy notifications, law enforcement investigations, and ransomware. Michael serves as outside general counsel for numerous national and international internet retailers, advising them on compliance issues and representing them in litigation matters.

As part of his dedication to community service, Michael served twelve years as a publicly-elected member of the University of Colorado Board of Regents. In 2012 and 2013, his colleagues elected him chair of the Board of Regents, which oversees the operations and multi-billion dollar budget of University of Colorado, the third largest employer in the state of Colorado. Michael has been interviewed on related issues by CNN, Fox News, The New York Times, The Los Angeles Times, and other media outlets. He is recently served as the Chair of the University of Colorado Law School Alumni Board and on the Board of Directors for Easter Seals Colorado. In 2023, Michael was jointly appointed by Colorado's Governor, Attorney General and Chief Justice for a six-year term on the Judicial Nominating Commission to help select trial judges in Denver.

#### Representative Matters

Defended large natural resources company in trade secret arbitration involving millions of dollars in royalties; claimant withdrew all claims after

arbitrator signaled intent to issue directed verdict in favor of Michael's client.

Defended multi-million dollar trust claim; following Michael's cross-examination at trial, petitioner voluntarily dismissed his claims and agreed to reimburse Michael's client for all fees and costs.

Successful representation of a CEO of a publicly traded company in an arbitration to secure the multi-million-dollar severance owed to him.

Represented internet marketing company in arbitration involving eight-figure arbitration against major social media company.

Multimillion-dollar verdict in client's favor following a two-week jury trial regarding breach of fiduciary duty claims.

A state prosecutor charged a construction contractor with two counts of felony theft of project funds. Mr. Carrigan was hired after a court bound the case over after a preliminary hearing. Mr. Carrigan coordinated a presentation of evidence that led the prosecution to dismiss the case in its entirety. He then filed a federal lawsuit against the complaining parties and promptly secured a seven-figure policy limits settlement by their insurer.

A small software company was the subject of a federal lawsuit seeking a restraining order and more than \$10 million in damages. Within three weeks, the temporary restraining order was defeated and the adverse party agreed to withdraw its complaint and stipulated to a \$1 million payment to Mr. Carrigan's client.

Successful defense of trade secret and non-complete claims, resulting in complete vindication and recovery of attorney fees for client.

An insurance brokerage was sued by a former client for numerous claims and asserted damages over \$4 million. Following dismissal of key through dispositive motions, Mr. Carrigan led a team through a nine-day jury trial, resulting in a total defense verdict after less than two hours of deliberations.
