This experience informs how he attacks and defends validity, shapes claim construction positions, and anticipates his opponents' arguments.

Grounded in his engineering physics background, Trevor speaks the language of his clients' innovations, including telecommunications, consumer electronics, standards and codecs (including IEEE 802.11), semiconductor design and fabrication, medical devices, and software. He is adept at translating complex technology into clear, persuasive terms for judges and juries.

Beyond the courtroom, Trevor maintains an active portfolio development and analysis practice, building patent protection aligned with clients' business objectives, and counsels on protection strategies in key international jurisdictions, including Europe, China, and Japan.
